ASSUMPTION OF RISK AND RELEASE OF LIABILITY AND MEDIA

In consideration of the services of Haggan Outrigger Canoe Club and its agents, owners, officers, volunteers, participants, employees and guests and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as the "Organizers"), I hereby agree to release, indemnify, and discharge the Organizers, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in outrigger paddling entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things: boat capsize; equipment malfunction; tidal conditions and currents; travel in remote areas; collision with objects or other water craft; prolonged exposure to cold water, hypothermia, accidental drowning; illness in remote areas; exposure to sun, strong wind, cold, storms, large waves, eddies and whirlpools, and lightning; aggressive and/or poisonous marine life; wrist, arm, shoulder, and/or back injuries; slips and falls while hiking; and rapidly changing adverse weather and water conditions. The foregoing list is not comprehensive, and there are other such risks. I also acknowledge that the Organizers have taken reasonable steps to ensure that each participant is physically able to safely participate, and I consider myself sufficiently fit to participate. If I have any known medical conditions that would affect my ability to safely participate, I will disclose those conditions to the Organizers in writing before I participate. Finally, I acknowledge that the Organizers have given warnings and instructions, and such warnings and instructions have been understood by me.
2. The Organizers are unaware of my or my minor child's fitness and abilities. I accept and assume all the risks of this activity, including any medical or physical condition I may have. My participation is purely voluntary, and I elect to participate in spite of the risks. I expressly agree and promise to accept and assume all of the risks existing in this activity. 3. The Organizers will use reasonable care to prevent harm to participants. However, the Organizers cannot guaranty against all risks to which a participant may be subject. Accordingly, to the fullest extent permitted by applicable law, I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the Organizers from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of the equipment or facilities. I hereby release and hold harmless the Organizers and any director, officer, affiliate or agent of the Organizers, from any cause of action or claim for damages of any nature whatsoever, whether or not apparent resulting from or arising out of any claimed injury or death to myself (or child) or damage to my property resulting in any claim that I, my relatives, my assigns, my heirs, my estate or other representatives may have in any way related to The Haggan Outrigger Canoe Club
4. Should the Organizers or anyone acting on their behalf, incur attorney's fees and costs to enforce this Participant Release, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage that I may cause or suffer while participating, or else I will bear the costs of such injury or damage myself.
6. I hereby grant to the Organizers and its representatives, agents, and assigns, the irrevocable and unrestricted right to use, reproduce and publish photographs of me, including my image and likeness as depicted therein, for editorial, trade, advertising or any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. I hereby release the Organizers from any and all claims, actions and liability relating to its use of said photographs. Likewise I acknowledged all of the above to apply to my child's participation.
7. SEVERABILITY: If any portion of this Participant Release is found to be void or unenforceable, the remaining portions will remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against the Organizers or any one of them on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
